This is a structured product that involves derivatives. Do not enter this trade unless you fully understand and are willing to assume the risks associated with it. HSBC India ("HSBC" /"Bank") provides foreign exchange risk management solutions to customers on a strictly non-advised basis.

## **Client's Exposure**

The Client needs to buy USD and sell INR and would like to manage the FX exposure. The Client is unsure of which direction USDINR will go and would like to retain full flexibility to benefit from a favourable Spot move. The Client is prepared to pay a premium and is willing to accept limited protection beyond a Cap in order to reduce the cost.

## **Product Description**

The Call Spread is a product designed for clients who want to mitigate/ partially cover an FX risk while enjoying full upside potential. By limiting the protection above the Cap Strike, the Client is able to access protection at the Strike Rate at a discounted premium compared to the vanilla option.

In this Strategy, the Client buys the USD at the Strike Rate provided that Spot at Expiry is below the Cap Strike and at or above the Strike Rate. If Spot at Expiry is at or above the Cap Strike, the Client buys USD at a rate equivalent to the Spot Rate plus a spread.

#### **Main Benefits**

- Potential to benefit from a favourable Spot Rate move
- Client has no obligation except payment of the premium

#### **Main Risks**

- If USDINR at expiry is above the Cap Strike. This will represent a loss as the Client has to buy USD at a hedge rate which is worse than the Par Forward at inception (see scenario #3)
- The Client has paid a premium for the option, which may not be recoverable

## **Trade Analysis**

- If the USDINR USDINR\_Spot Rate at Expiry Time on the Expiry Date is trading at or above the Strike Rate and below the Cap Strike, Client buys USD Notional Amount and sells INR at the Strike Rate and is protected at this rate
- If the USDINR USDINR\_Spot Rate at Expiry Time on the Expiry Date is trading at or above the Cap Strike, Client receives in INR the amount of Notional Amount \* (Cap Strike Strike Rate) and the protection is limited.
- If the USDINR USDINR\_Spot Rate at Expiry Time on the Expiry Date is trading below the Strike Rate, there is no FX transaction. The Client is free to buy USD and sell INR at the prevailing Spot Rate, benefiting from a favourable move

# Scenario Analysis

The following analysis is produced for illustrative purposes only, and does not reflect a complete analysis of all possible opportunity gain and loss scenarios that may arise under the actual hedge structure. No representation or warranty is made by The Hongkong and Shanghai Banking Corporation Limited in India ("HSBC" or "HSBC India") that any scenario shown below can be duplicated under the actual structure. Actual results may vary from the results shown below, and

variations may be material. The scenario analysis only illustrates potential outcomes on expiration dates and is not considered a reflection of the mark-to-market value nor the unwind cost which depends on additional market factors (refer sections on Scenario Analysis, Unwind Costs and the appendix attached separately). The unwind cost of the product can fluctuate either upward or downward due to changes in prevailing market conditions. Accordingly, if the hedge structure set out herein is unwound prior to its stated maturity, you may sustain a loss which may well exceed the amount you receive under the said structure.

#### **Worst Case Scenario**

In the worst case, the option expires worthless and Client does not recover the premium.

## **Liquidity/ Unwind Costs**

The Client should only purchase an option if the Client is prepared to keep it for the length of the term. If the Client wants to terminate the option early, the Client will not be required to pay any unwind cost but the Client may not get anything from HSBC potentially resulting in a net loss for the Client.

When HSBC enters into an option contract with the Client, HSBC generally hedges its position to manage its own risk. If the Client terminates the transaction, HSBC will no longer need to manage this risk but will still have the hedge positions open, so HSBC will need to terminate its hedging contract. When HSBC terminates or otherwise adjusts its own hedge, HSBC will be impacted by market values and other factors (including, but not limited to, the availability of equivalent hedge positions and its own funding costs and creditworthiness) which might affect the residual value of the position.

Depending on the market parameters including but not limited to prevailing market interest rates, market volatility, the residual value of the option can be higher than the original premium paid by the Client or a substantially lower fraction of the premium originally paid by the Client or even zero. In any circumstance, the residual value of the option cannot be lower than zero. It means that the Client will not be required to pay any unwind cost upon termination in any circumstances.

#### **RISK DISCLOSURE STATEMENT**

#### **Derivatives / Market Risks**

This transaction contains derivative instruments whose values are sensitive to changes to market factors. If the transaction involves exposure to foreign currency risk or is settled in a foreign currency, the Client may suffer a loss as a result of exchange rate fluctuations. At times of high market volatility the changes in valuation can be very significant. While we may provide mark-to-market valuation on the transaction from time to time, we are not obliged to do so; and given the bilateral, over-the-counter nature of the trade, the Client may find it difficult to obtain a valuation from another independent source. Moreover, the value or price of the transaction (in relation to, for example, any mark-to-market determinations, or restructuring or unwind requests) may be calculated by reference to, or by discounting using, one or more benchmark or rate curves, as applicable. Such benchmarks or rates may be discontinued in the future or may over time no longer be appropriate, as determined by HSBC. As a result, HSBC may in the future apply a different discounting methodology, which may result in a different valuation or price.

The value of the transaction is determined by the prevailing market rates of different parameters reflecting the market conditions at the time, as well as the terms and the remaining tenor of the transaction (which may have been impacted by market movements since the inception of the trade) as described in the "Derivatives / Market Risks" section. Therefore, the value of the transaction could be impacted by various parameters (if applicable) at the time of calculation including but not limited to:

Spot rate or price; strike rate or price; forward rate or price; volatility; interest rates

The sensitivity to some of the above parameters (as on inception) is as below:

#### USD 2.056.699.93 Delta is calculated by taking the first order derivative value of the underlying derivative price with respect to spot rate. This could change during the tenor of the transaction subject to market parameters changing. To illustrate, for the purposes of this transaction, if there is a small increase in spot rate: Delta (calculated a positive Delta means such small increase in spot rate will result in an increase in the from the Client's underlying derivative price; and point of view as at Trade Date) a negative Delta means such small increase in spot rate will result in a decrease in underlying derivative price. The above illustration assumes a small increase in spot rate. If there is a large movement in spot rate, both the direction and/or the magnitude of the change in underlying derivative price as a result of the movement in spot rate may be different from the above. USD -3,346.84 Vega is calculated by taking the first order derivative value of the underlying derivative price with respect to implied volatility. This could change during the tenor of the transaction subject to market parameters changing. To illustrate, for the purposes of this transaction, if there is a small increase in implied volatility: Vega (calculated a positive Vega means such small increase in implied volatility will result in an increase from the Client's in the underlying derivative price; and point of view as at **Trade Date)** a negative Vega means such small increase in implied volatility will result in a decrease in underlying derivative price. The above illustration assumes a small increase in implied volatility. If there is a large movement in implied volatility, both the direction and/or the magnitude of the change in underlying derivative price as a result of the movement in implied volatility may be different from the above.

## **HSBC** Hedging Activities
